1. General

Javelin Medical Ltd. (“**company**”, “**we**”, “**us**”) value your privacy and is committed to protecting personal data related to you. This privacy notice (“**Notice**”) sets out our privacy practices as a data controller for the processing of personal data related to you when you visit and use our following websites, any of our other online properties, or when you communicate with us (“**Websites**”):

In this Notice, “**Personal data**” means any data related to you that either identifies or can identify you; and “**Processing**” means within the meaning of this Notice, means any action performed on personal data.

Unless indicated otherwise, our processing of personal data about you is subject to your consent, which you provide us when you use our Websites. You are under no legal obligation to provide us with personal data related to you. If, after reading this Notice, you find that our privacy practices do not align with your views or wishes, you may not use, visit, or access our Websites.

The following is a summary of our practices. Please take the time to read our full notice.

- **What Data We Process.** We collect personal data you provide when you enter the Websites.

2. What Personal Data Do We Process?

We process the following personal data related to you:

- Personal data such as your name, email address, and any other personal data that you provide when you fill in our contact form, or when you send us an email.
- Any additional personal data related to you that you enter on our Websites or provide us in any other way through the Websites.
- Traffic data that your online activities generate, such as IP addresses, browser information, session durations, and viewed pages.

3. For What Purposes Do We Process Personal Data Related to You?


We process personal data related to you to provide you with the Websites, comply with a legal obligation, and to protect your and others' vital interests, such as:

- To operate and enable our Websites and to improve and customize your experience with them.
- To reply to messages that you send us through our forms and correspond with you.
- To protect and enforce the rights and interests of our employees, users, suppliers, affiliates, business partners, and our own rights and interests, and to take any action in any case of dispute or legal proceeding.
- To prevent and remediate fraud, misappropriation, infringements, violations, identity theft, cyber-attacks, and other security incidents, illegal activities and misuse or abuse of our Websites.
- To comply with any requests and orders of law enforcement agencies and authorities.

4. How Do We Share Personal Data Related to You?

We do not sell, rent, or lease personal data related to you. We share personal data related to you for the following purposes:

- We share personal data related to you with third-party service providers to help us operate, manage, and protect our Websites and our operations. They provide us with services such as analytics, information security and IT support.
- We also share personal data related to you with our affiliates, for business purposes, with the express provision that their use of personal data related to you will comply with this Notice.
- We do not use analytics other similar tools on our Websites, and all cookies and other tracking tools implemented on our website are implemented either to provide the website or for data security.

5. What Are Your Rights?

- Right to Review Personal Data. You have the right to review the personal data related to you that we keep, subject to certain applicable legal limitations. We will ask you to provide certain credentials to verify your identity. If required under applicable law, we will make good-faith efforts to locate and provide you with a copy of personal data related to you that you request, and that resides in our information systems.
- Right to Correct Personal Data. If you find that any of the personal data related to you is inaccurate, incomplete, unclear, or outdated, you may request that this personal data be corrected or deleted. If we decide to refuse your request, we will notify you of our refusal in accordance with applicable law, and you may appeal our decision.
- Right to Delete Personal Data Transferred From the EEA. If personal data related to you is transferred to us from the European Economic Area (EEA) by a source other than yourself or stored in an Israeli database that includes such EEA-originating personal data, you have the right to request its deletion. Such a deletion request is subject to limitations under applicable laws.

6. Aggregated and Analytical Data

We use anonymous, statistical, and aggregated data that we derive from personal data related to you to drive insights, statistics, trends, and predictions for our internal use (including for data security purposes), and we will share it at our discretion for lawful business purposes and subject to applicable law.


7. For How Long Do We Keep Personal Data?

We retain personal data for as long as necessary to fulfill the purposes of using such data under this Notice and as permitted by law. Contact information that you provide us is necessary for providing you with the Websites or corresponding with you, but we will delete such data upon your written request.

8. Transfer of Data Outside Your Territory

We may store and process personal data in various sites throughout the globe and in sites operated and maintained by cloud-based service providers, including in the United States, and for such purpose, transfer personal data related to you to such territories.

Depending on applicable law, such a transfer of personal data is subject to certain conditions. By using our Websites you hereby provide us with the necessary consent for such transfer of personal data.
